



## OFS Credit Company Announces Results of Stockholder Elections for the Distribution for the Quarter Ending July 31, 2020

CHICAGO--(BUSINESS WIRE)--Jul. 22, 2020-- OFS Credit Company, Inc. (NASDAQ: OCCI) ("OFS Credit," the "Company," "we," "us" or "our"), an investment company that primarily invests in collateralized loan obligation ("CLO") equity and debt securities, today announced the results of stockholder elections for the \$0.52 per common share distribution declared by the Company's Board of Directors on May 26, 2020. Stockholders had until July 16, 2020, to elect whether to receive the distribution in cash (up to an aggregate maximum cash amount of 10% of the total distribution), excluding any cash paid for fractional shares, or in shares of the Company's common stock. The distribution is payable on July 31, 2020, to common stockholders of record as of June 16, 2020.

The distribution will consist of approximately \$0.17 million in cash and 168,729 shares of common stock, or approximately 5.2% of the Company's outstanding common stock prior to the distribution. The amount of cash elected to be received was greater than the cash limit of 10% of the aggregate distribution amount, therefore resulting in the payment of a combination of cash and stock to stockholders who elected to receive cash. The number of shares of common stock comprising the stock portion was calculated based on a price of \$9.00 per share, which equaled the volume weighted average trading price per share of the Company's common stock on the Nasdaq Capital Market on July 15, 16 and 17, 2020.

Stockholders who elected to receive the distribution solely in shares of common stock and stockholders who did not make an election will receive approximately 0.05778 shares of common stock for each share of common stock they owned on the record date of June 16, 2020. Holders of approximately 31.2% of the Company's common stock elected to receive only stock or did not make an election.

Stockholders electing to receive the distribution in all cash will receive cash in the amount of \$0.075531 per common share, or approximately 14.5% of the \$0.52 distribution, and 0.444469 shares of common stock, or approximately 85.5% of the total distribution for each share of common stock they owned on the record date of June 16, 2020. Cash in lieu of fractional shares will be issued, if applicable. Total outstanding shares of the Company's common stock following the distribution will be approximately 3,413,558.

The Company's investment objective is to generate current income, with a secondary objective to generate capital appreciation primarily through investment in CLO debt and subordinated securities. The Company's investment activities are managed by OFS Capital Management, LLC, an investment adviser registered under the Investment Advisers Act of 1940<sup>1</sup>, as amended, and headquartered in Chicago, Illinois with additional offices in New York and Los Angeles.
